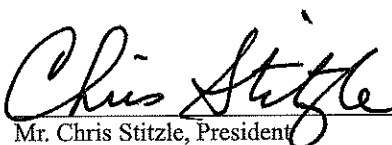

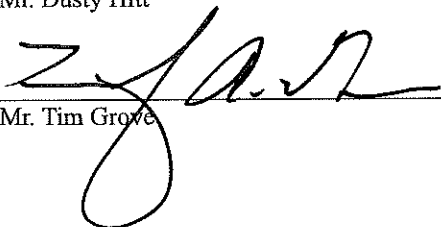
Mr. Larkin made a motion to adjourn. Mr. Jeff Gambill seconded the motion. The meeting was adjourned at 11:15 a.m..
